We ask all our clients, especially new clients, to fill in our client tax organizer and return it to us. A link to the organizer is available below, in the first step. Please save it to your computer, fill it in, and return it to us. If you have any questions, do not he sitate to contact us.

- Open the client tax organizer at <a href="http://palazzotax.com/forms/">http://palazzotax.com/forms/</a> and save to your computer. (we can email if preferred)
- Review, complete, and return the client tax organizer
- Sign and return engagement letter (attached)
- Email, fax or mail W-2s, 1099s, and prior year tax returns (copies only)
- Go online to make payment or telephone in payment to 866-272-9224 see Pay Online at <a href="http://www.palazzotax.com/pay-online/">http://www.palazzotax.com/pay-online/</a>
- Once client tax organizer, support, signed engagement letter, and payment is received we will prepare return
- We will ask questions and answer questions as needed
- We will send you a review copy via email
- Upon written authorization from you we will electronically file returns
- Keep in mind no action is taken without your permission
- Extensions will automatically be filed if return is not prepared by the filing deadline (Expats overseas on April 15<sup>th</sup> have until June 15<sup>th</sup> to file without penalty)

Our experience and customer service is unmatched in the industry we serve. The fee for a US tax return starts at \$350, and the fee for an Expat tax return begins at \$500. This will cover your federal and one state tax return, e-filing, and extensions. **See client tax organizer for additional fees.** 

We must receive all information to prepare your return by March 15 to ensure that your return will be completed by April 15. If we have not received all of your information by March 15, and your return is not completed by April 15, you may be subject to late filing or late payment penalties.

It is your responsibility to inform us if you are required to file a locality, city, or school district tax return. These returns are not included with your standard tax preparation. We can assist you with preparing these returns for a nominal fee. Please let us know if you are required to file this type of return.
